



**Bloomberg Commodity Index Price Index in USD:** The Bloomberg Commodity Index(BCOM) is a highly liquid and diversified benchmark for commodity investments. BCOM provides broad-based exposure to commodities, and no single commodity or commodity sector dominates the Index. Rather than being driven by micro-economic events affecting one commodity market or sector, the diversified commodity exposure of BCOM potentially reduces volatility in comparison with non-diversified commodity investments.

**Bloomberg U.S. Aggregate Total Return in USD:** The Bloomberg US Aggregate Bond Index is a broad-based flagship benchmark that measures the investment grade, US dollar-denominated, fixed-rate taxable bond market. The index includes Treasuries, government-related and corporate securities, fixed-rate agency MBS, ABS and CMBS (agency and non-agency). Provided the necessary inclusion rules are met, US Aggregate-eligible securities also contribute to the multi-currency Global Aggregate Index and the US Universal Index. The US Aggregate Index was created in 1986, with history backfilled to January 1, 1976.

FTSE NAREIT All Equity REITS Gross Return in USD: The FTSE Nareit US Real Estate Index Series is designed to present investors with a comprehensive family of REIT performance indexes that spans the commercial real estate space across the US economy. The index series provides investors with exposure to all investment and

property sectors. In addition, the more narrowly focused property sector and sub-sector indexes provide the facility to concentrate commercial real estate exposure in more selected markets. The FTSE Nareit All Equity REITs index contains all tax-qualified REITs with more than 50 percent of total assets in qualifying real estate assets other than mortgages secured by real property that also meet minimum size and liquidity criteria.

**HFRI FOF: Diversified Index Total Return in USD:** FOFs classified as 'Diversified' exhibit one or more of the following characteristics: invests in a variety of strategies among multiple managers; historical annual return and/or a standard deviation generally similar to the HFRI Fund of Fund Composite index; demonstrates generally close performance and returns distribution correlation to the HFRI Fund of Fund Composite Index. A fund in the HFRI FOF Diversified Index tends to show minimal loss in down markets while achieving superior returns in up markets.

**Russell Midcap Gross Return in USD:** The Russell Midcap Index measures the performance of the mid-cap segment of the U.S. equity universe. The Russell Midcap Index is a subset of the Russell 1000® Index. It includes approximately 800 of the smallest securities based on a combination of their market cap and current index membership. The Russell Midcap Index represents approximately 31% of the total market capitalization of the Russell 1000 companies. The Russell Midcap Index is constructed to provide a comprehensive and unbiased barometer for the mid-cap segment. The Index is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true mid-cap opportunity set.

**S&P 500 Gross Return in USD:** The S&P 500<sup>®</sup> is widely regarded as the best single gauge of large-cap U.S. equities. There is over USD 9.9 trillion indexed or benchmarked to the index, with indexed assets comprising approximately USD 3.4 trillion of this total. The index includes 500 leading companies and captures approximately 80% coverage of available market capitalization.

LIBOR Discontinuance: The LIBOR rate is intended to represent the rate at which contributing banks may obtain short-term borrowings from each other in the London interbank market. The U.K. Financial Conduct Authority has publicly announced that certain tenors and currencies of LIBOR will cease to be published or representative of the underlying market and economic reality they are intended to measure on certain future dates; current information about these dates is available at https://www.jpmorgan.com/disclosures/interbank\_offered\_rates. **SOFR:** The Secured Overnight Financing Rate (SOFR) is a broad measure of the cost of borrowing cash overnight collateralized by Treasury securities.

#### **RISK MEASURE DEFINITIONS**

Alpha: A measure of the portfolio's excess return relative to the return of the benchmark.

**Annualized Volatility:** Otherwise known as standard deviation, it is a measure of return dispersion. The larger the number, the more volatile the returns. A representative sample of observations is needed to estimate this dispersion.

Best Month: Highest monthly percentage return.

**Beta:** A measure of portfolio volatility in comparison to the benchmark. A beta of less than one indicates the portfolio is less volatile than the benchmark. A beta of greater than one indicates the portfolio is more volatile than the benchmark.

**Correlation:** A measure of directional co-movement between the portfolio and the benchmark. The range of possible correlations is between -1 and +1. A result of -1 means a perfect negative correlation and +1 means a perfect positive correlation.

**Down Market Capture:** For the months in which the Benchmark had negative returns, the selected account(s) or group(s)'s gross (or net) returns divided by the Benchmark's returns. A Down Market Capture of less than 100% shows that, when the market went down, the selected account(s) or group(s) lost less than the Benchmark (except that the Down Market Capture is a negative number if the selected account(s) or group(s) had positive returns while the Benchmark had negative returns). A Down Market Capture of more than 100% shows that, when the market went down, the selected account(s) or group(s) lost more than 100% shows that, when the market went down, the selected account(s) or group(s) lost more than the Benchmark.

Information Ratio: A measure of value added by the manager. It is the ratio of excess return to tracking error.

Maximum Drawdown: Largest cumulative percentage loss experienced by the portfolio in consecutive months with negative return.

Sharpe Ratio: A measure of risk-adjusted performance, using the ICE BofA US 3-Month Treasury Bill Index for the risk-free rate.

**Tracking Error:** A measure of how closely the portfolio's returns track the returns of a benchmark. It is the standard deviation of excess returns over a benchmark.

Up Market Capture: For the months in which the Benchmark had positive returns, the selected account(s) or

group(s)'s gross (or net) returns divided by the Benchmark's returns. An Up Market Capture of more than 100% shows that, when the market went up, the selected account(s) or group(s) performed better than the Benchmark. An Up Market Capture of less than 100% shows that, when the market went up, the selected account(s) or group(s) performed worse than the Benchmark.

Worst Month: Lowest monthly percentage return.

% of Positive Months: A measure of the number of times the portfolio had a positive return compared with the total number of returns to date.

Accrued Income: It is the income which has been earned but not yet received

Alloc (%): It is the asset allocation as of the specified date.















**SOFR:** The Secured Overnight Financing Rate (SOFR) is a broad measure of the cost of borrowing cash overnight collateralized by Treasury securities.

#### **RISK MEASURE DEFINITIONS**

Alpha: A measure of the portfolio's excess return relative to the return of the benchmark.

**Annualized Volatility:** Otherwise known as standard deviation, it is a measure of return dispersion. The larger the number, the more volatile the returns. A representative sample of observations is needed to estimate this dispersion.

Best Month: Highest monthly percentage return.

**Beta:** A measure of portfolio volatility in comparison to the benchmark. A beta of less than one indicates the portfolio is less volatile than the benchmark. A beta of greater than one indicates the portfolio is more volatile than the benchmark.

**Correlation:** A measure of directional co-movement between the portfolio and the benchmark. The range of possible correlations is between -1 and +1. A result of -1 means a perfect negative correlation and +1 means a perfect positive correlation.

**Down Market Capture:** For the months in which the Benchmark had negative returns, the selected account(s) or group(s)'s gross (or net) returns divided by the Benchmark's returns. A Down Market Capture of less than 100% shows that, when the market went down, the selected account(s) or group(s) lost less than the Benchmark (except that the Down Market Capture is a negative number if the selected account(s) or group(s) had positive returns while the Benchmark had negative returns). A Down Market Capture of more than 100% shows that, when the market went down, the selected account(s) or group(s) lost more than 100% shows that, when the market went down, the selected account(s) or group(s) lost more than the Benchmark.

Information Ratio: A measure of value added by the manager. It is the ratio of excess return to tracking error.

Maximum Drawdown: Largest cumulative percentage loss experienced by the portfolio in consecutive months with negative return.

Sharpe Ratio: A measure of risk-adjusted performance, using the ICE BofA US 3-Month Treasury Bill Index for the risk-free rate.

**Tracking Error:** A measure of how closely the portfolio's returns track the returns of a benchmark. It is the standard deviation of excess returns over a benchmark.

Up Market Capture: For the months in which the Benchmark had positive returns, the selected account(s) or

group(s)'s gross (or net) returns divided by the Benchmark's returns. An Up Market Capture of more than 100% shows that, when the market went up, the selected account(s) or group(s) performed better than the Benchmark. An Up Market Capture of less than 100% shows that, when the market went up, the selected account(s) or group(s) performed worse than the Benchmark.

Worst Month: Lowest monthly percentage return.

% of Positive Months: A measure of the number of times the portfolio had a positive return compared with the total number of returns to date.

#### ADDITIONAL DEFINITIONS

Accrued Income: It is the income which has been earned but not yet received

Alloc (%): It is the asset allocation as of the specified date.

**Cash Balance:** It is the value of your US Dollar cash and Money Market sweep position(s) except any short term positions you hold, as of the date of this report, of all accounts covered by this report.

Cost: It is the total cost of all of a particular type of security in your portfolio.

Returns are geometrically linked to calculate for longer time periods. Time-weighted rate of returns are used in this report unless otherwise indicated.

**Money-weighted rate of return (MWRR)** is a measure of the performance of a client portfolio taking into account the timing of the inflow and outflows for the entire investment time horizon selected. The MWRR is calculated by finding the rate of return that will set the present values (PV) of all cash flows equal to the value of the initial investment. The MWRR is equivalent to the internal rate of return (IRR). The MWRR and TWRR will differ as clients contribute to and withdraw assets from their investment portfolio. The MWRR can be contrasted with the time-weighted return (TWRR), which removes the effects of cash in- and outflows, for the same time period.

Pages indicated with a **"Preliminary: Data subject to verification"** banner are representing data that is subject to verification and may change. **Previous business day performance and market value** numbers are also preliminary. For verified performance returns, please refer to the month end performance results.

**Performance Contribution** is the portion of your overall portfolio rate of return since inception that is attributed to each asset class or product. 


